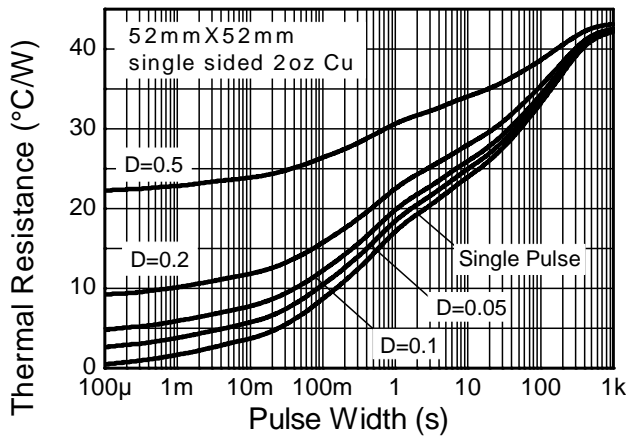

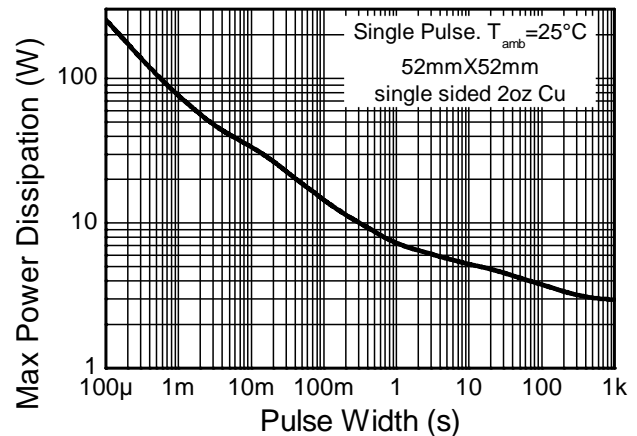
Safe Operating Area

Transient Thermal Impedance



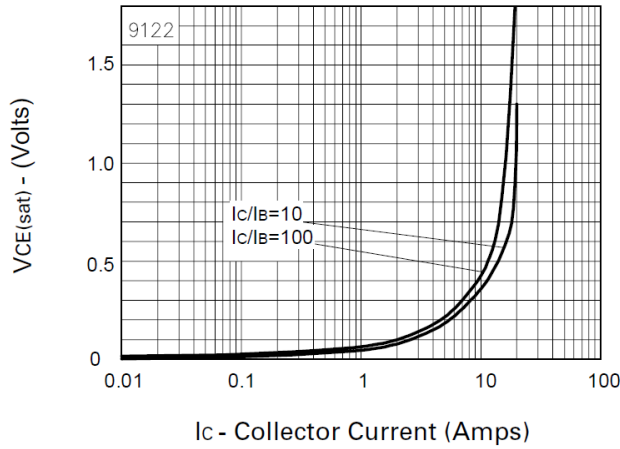

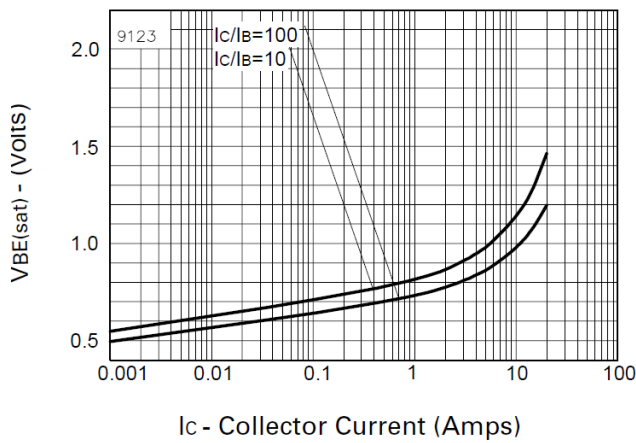

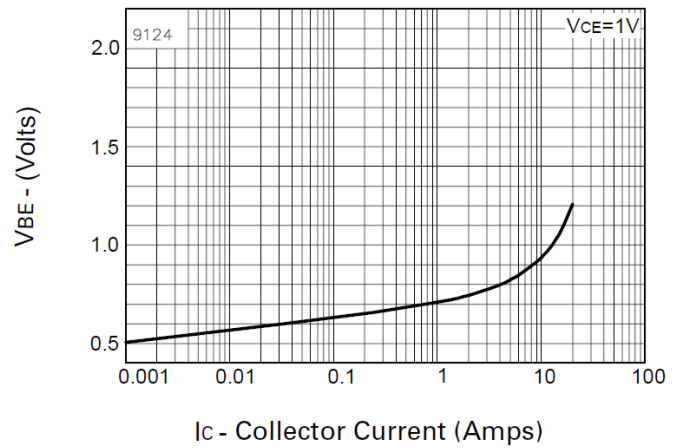
VCE(sat) v IC



hFE v IC



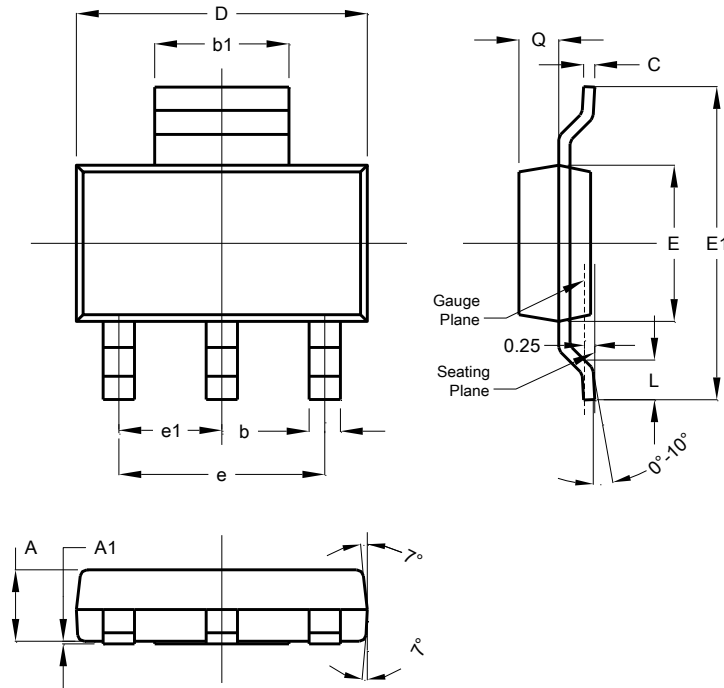
VBE(sat) v IC

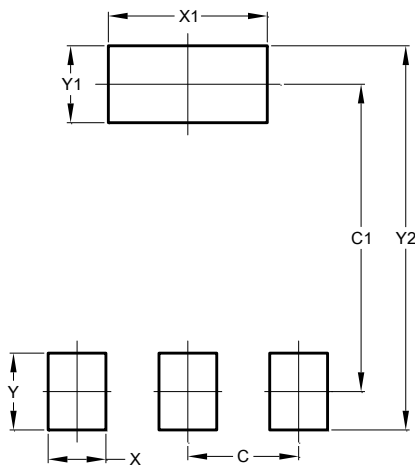
